4. Presentation of summary PCC accounts, year ended 31st Dec 2023

By Dave Thebridge, interim Treasurer (since autumn 2023)

- Restricted funds explained
- Massive increase in costs.
- Investments down because of war in Ukraine.
- New accounting system (My Fund Accounting) adopted as recommended by diocese.
 Considerable work to allocate transactions to new columns etc. Now more or less in place and will be able shortly to get accounts to independent examiner.
- Quinquennial works and new boiler budgeted and allowed for in our losses.
- Energy bills will increase now as long-term contracts come to an end.

Report of Priest-in-charge to APCM of Holy Trinity Parish Church Sutton Coldfield - April 2025

As part of the diocesan strategy, People and Places, the Oversight Area sees Holy Trinity, St Peter's, St Chad's and Emmanuel, Wylde Green working together with an allocation of 3 full time stipendiary clergy. I remain as the Priest in Charge of Holy Trinity and Vicar of St Peter's, Maney, as we continue through this discernment phase. In September 2024 we welcomed Fr Graham Wigley, who alongside his role of Vicar of Emmanuel, Wylde Green, is also Associate Priest at Holy Trinity.

Since I have responsibilities for 2 congregations, the pattern of worship decided is that I will lead services on the 1st and 3rd Sundays. Revd Carol Hoare would continue to offer monthly services on the 4th Sunday of the month, and the 2nd Sunday would be led by Fr Graham. Revd Paul Duckers continues to lead worship, and Stella Thebridge and Susie Walker lead services on Sunday evenings.

JCYG is now being run by Christina Brown. Christina is the Youth Worker of St Peter's, Maney. CYG is now called OYG (Oversight Youth Group) and meets fortnightly. The group is currently very well attended and has a focus on sharing food and faith.

We continue to look at ways to make our church building more sustainable and to honour the fifth mark of mission, to strive to safeguard the integrity of creation. Our thanks to Jean Soper who has once again taken on the role of Eco Advocate as we seek to reach the Gold Eco Church award. This will be one of our main objectives in the coming year.

The following reports highlights some of the wonderful events and services which have been held at Holy Trinity during the past year. There are so many gifted and dedicated people who give of their time, gifts and resources in so many ways. It has been wonderful to see a full programme of events from the Friends. Merry Messy Christmas was very well received, as was the Heritage Day in September. We also marked the 80th anniversary of the D Day landings with a beacon lighting, provided by the Town Council.

The people of Holy Trinity are the Church, the body of Christ. When we lose members of our church family, there is great sadness. Last year, we lost Anne Storey, who had worshipped here for over 30 years. Also, Jean Mewett and David Gale, who were long time members of this church. More recently, we have heard about the sad death of Jean Schneider who was a committed member of the choir.

We have welcomed new members to our church family, and we are so very thankful that we have seen the number of worshippers rising each Sunday.

I have been extremely grateful for the support and commitment of so many people, too many to mention. I do however want to especially thank our churchwardens, Stella Thebridge and Jean Soper, who work hard to ensure the smooth running of the church and services, as well as Paul, Carol and Averil who continue to serve us all with grace. They have each been a huge blessing to me and the church. It is a huge privilege to minister in this place. My hope and prayer for the future is that we continue to grow, not only in number but also in love; in love of one another, in love of God and in love of our neighbours. Then we will be building the Kingdom of God in Sutton Coldfield.

Holy Trinity Parish Church Sutton Coldfield Churchwardens' Report on the Church fabric, ornaments, Trinity Centre and grounds Rev'd Canon Becky Stephens

APCM 6th April 2025

We received the annual Visitation from Ann Richardson (Area Dean) in lieu of the new Archdeacon on 13th November 2024. She inspected our processes, registers, log book and inventory and found everything in order.

Our responsibility for all these parts of the church estate is fortunately facilitated by the Buildings Sub-Committee of the PCC and our able Parish Administrator and Site Facilitator. This is all overseen by Revd Canon Becky Stephens, our priest-in-charge who deals with faculty applications and our architect and the Diocesan Advisory Committee (DAC).

Wardens' duties

In our role to oversee the buildings and fabric of the buildings and site, we undertake a range of tasks. With the able assistance of 4 deputies we try to support the clergy and ensure that all services run smoothly. We look out for newcomers and try to chat to them and keep up with those who might be absent unexpectedly.

We have prepared for large services, e.g. Bishop Vesey Grammar School Founder's Day service, Remembrance Sunday and the Carol service, by moving chairs, allocating seats and engaging stewards as required.

Guidelines for wardens, deputies and chalice assistants have been updated. These are very useful for those who are new to the roles, as is the training and support that is offered.

We applied to the Harlow Trust for a grant to run activities for children that would help them appreciate the Eucharist, and have been given an award for activities which will start after Easter.

We contribute to the 4-monthly worship plans providing rotas for wardens, stewards, readers and those leading intercessions. We try to involve as many people as possible in roles that they are willing to undertake, subject to Becky's oversight.

There are ongoing difficulties with unlocking/locking and opening the main safe in the clergy vestry. This is a problem when it occurs immediately before a communion service. We are trying to resolve this with better storage arrangements in the range of safes that we have in the vestry.

We have set up a system of covering the main altar with a purple cloth after each service to prevent plaster and dust from the roof landing on the linen (the cloth was kindly sourced by Becky).

We have started a review of emergency evacuation procedures as part of a wider disaster management process. We have inspected the various exit doors of the church and made recommendations to improve access to them and their locking systems, to make them as accessible as possible as emergency exits.

There have been purchases, repairs and annual inspections, for both buildings as well as in the grounds. Work has been carried out either by us or on our behalf by contractors, our Parish Administrator and Site Facilitator or members of the congregation, as follows:

Trinity Centre

- 4 over door heaters fitted to the Trinity Suite to aid with the heating due to a failing boiler system in Oct 2024
- BT –old accounts closed and bills now reduced dramatically, securing a contract till 2029. Now on BT cloud voice and full fibre enhanced
- gas and electricity signed up to a three-year contract with Eon ending 2027

- Servicing of alarm systems and fire extinguishers, gas appliances, heating boilers and systems, air conditioning, lift (awaiting lighting installation subject to legal requirements), room dividers, lightning conductors (new conductors installed Oct 2024. 1-year free maintenance check and five-year guarantee on installation), PAT testing
- cardboard and plastic recycling bins received free of charge from Bham City Council
- a bid has gone to SCCT to upgrade the centre with new carpet tiled entrance, curtains, carpet and paint throughout the building.

Church:

Faculties obtained by Revd Canon Becky Stephens for:

- Repair of clergy vestry roof
- assessment and restoration of 18th cent coat of arms
- new altar table for Vesey Chapel
- installation of a CCTV camera in church entrance (to face away from inner doors to outer doors)
- three new pulpit falls (white, green and red) to complement the purple fall made at the time of re-ordering by Ann Howden, who is making these too. The white fall was completed for Christmas 2024 and the others are hoped to be ready for Trinity Sunday in June 2025.

Other in church

- Servicing of lightning conductors
- PAT testing
- servicing of fire extinguishers re-siting of two in January 2025
- Servicing of heating and extensive investigation of system failures with associated repair work
- addition of four emergency lighting units
- preparation for repair of leaking clergy vestry roof
- Tuning of piano.

Inventory

A thorough check of the inventory and condition of the contents of the church was undertaken on 8th March by the wardens, two deputies and 2 others. Noted changes were the sale or disposal of the former congregational hymn books (in the TC basement for at least the last ten years.) Some damaged linen has been discarded as have pulpit falls, veils and burses as the new ones are made. Care has been taken to try to find homes for items where possible. Communion sets described as "on loan to Good Hope Hospital since 2008" are being 'chased' with the current chaplain. We would recommend that these are deemed a gift to the Hospital, if found, and are removed from the inventory in any case.

There were no missing items except one or two hymn books (word version).

Break-in to Trinity Centre

Following this event in November 2024, some repairs are being effected in line with both requirements of the insurers and compliance with conservation area restrictions. We hope to

have work completed soon. While it was a stressful and sad moment, we are grateful that it only created damage to the Trinity centre and that it is all reparable. We have taken the opportunity to review security in both the TC and church as a result. We are enormously grateful to those who undertook a through clean up to enable bookings to continue uninterrupted in the Centre.

A bid has been submitted to SCCT to support major repair and refurbishment of the Trinity Centre, hopefully to take place in August 2025.

Grounds:

Discussions are ongoing about both the transfer of the Vesey Gardens to the local Town Council and the repairs by Birmingham City Council to the boundary wall.

Birmingham City Council park rangers continue to oversee the cutting of grass in the churchyard.

John Wright has overseen weekly maintenance work in the grounds including litter-picking, some pruning and general tidying. We are very grateful to him, Karen Wright and Alison Latham who assist in this, as well as to those who have helped through eco activities including Jean Soper and Paul Medlicott.

The church cleaning team are unsung heroes and heroines, keeping the church tidy as well as cleaning the silver and dusting ornaments. They meet on alternate Wednesday mornings. Our paid cleaners look after the Trinity Centre and the toilets and kitchen area of the church. We thank all those who give their time and effort in this way and are grateful to Barry Ulyatt for regular repairs to the vacuum cleaners and a lovely thorough clean of the cross in 2024 that stands under the East window. Plans are in hand to buy one new heavier duty vacuum cleaner. More volunteers would be most welcome in either church cleaning or looking after the grounds.

In recognition that Becky ministers across two churches, we are hugely grateful to Paul Duckers and Carol Hoare who continue to offer their priestly ministry at Holy Trinity as Assistant Priests. We were also delighted to welcome Fr Graham Wigley as Associate Priest in September. Fr Graham is also the Vicar of Emmanuel Wylde Green.

Following a trial of *All In* services, the committee recommended to the PCC that we move to have just 4 *All In* services per year:

Mothering Sunday
Harvest Festival
Toy Service
One other to be set in the summer months.

Our general worship pattern has now been set at:

Becky to take the 1st & 3rd Sunday, Fr Graham to take the 2nd Sunday Carol to take 4th Sundays

Now that we have appointed a new Director of Music, the band meets to rehearsal each month. The band then plays during the service on the 3rd Sunday.

An evening service has been re-introduced on the 2nd Sunday monthly at 5.30pm. These services range in worship style and are led by Stella Thebridge, Susie Walker, Becky and Fr Graham. If there is a Service of the Word at 10am, the evening service will be Holy Communion.

Stella Thebridge was commissioned as a Worship Leader in January 2025 following a Growing Gifts with CofE Birmingham. This has enables a variety of services to take place in the evening service.

During the year, we held numerous services including:

Bishop Vesey Grammar School's Founders Day, Remembrance Sunday and two services held by the Hugh Sheriff of the West Midlands, Doug Wright (supported by Becky as his chaplain) and the Civic Service which included the inauguration of a High Steward of Sutton Coldfield, Lord Norman Fowler.

We have commissioned Ann Howden to make 3 pulpit falls, green, white and red so that we have liturgical colours visible. We have also reintroduced using a burse and veil at the Eucharist.

Study

We held Oversight Area Bible study sessions in 2024 which were well attended. In 2025 we will run sessions on Atonement.

Becky and Graham will be attending training to lead *Being With*, a discipleship course created by St Martin's in the Fields. This will run in the summer.

Oversight Area

We are now formed as an Oversight Area with St Peter's, Maney, Emmanuel, Wylde Green and St Chad's, Sutton Coldfield. Jean Soper, Louise Chubb and Sue Ingley attended a formation day alongside Becky and Graham where we considered our parishes and held conversations to find ways to work together.

The agreed areas of mission are:

Children and Young People, Discipleship and Eco.

We have begun a Youth group for secondary aged children, which is currently held at St Chad's church, twice a month. We are planning to hold joint discipleship courses and Revd Jonathan Nicholas is planning to lead on Eco Church.

The oversight area ministers (including Readers and commissioned worship leaders) meet for Morning Prayer on a Wednesday and Becky, Graham and Jonathan meet monthly for planning and prayer.

Media

We suspended our Twitter account due to recent activity from its CEO. Louise Chubb has created a Threads account which is run by Meta. We continue to have Facebook and Instagram accounts run by Louise Chubb and Johanna Medlicott.

During this year, it became essential that we changed the host for our website. M3 we're seeking £40,000 to update and support the site, along with a monthly fee. We are hugely grateful to Chris Chubb who worked hard to create a new website, hosted by Wix. This is at a fraction of the cost. Work is ongoing to finalise the site following it going live in February 2025. The new site means we can take payments for tickets etc, as well as donations. The online query form had also been updated and has proved to be popular in making enquiries about hall bookings.

The Trinity Magazine continues to be published bi monthly and is always of high quality. With thanks to the editors Louise Chubb, Johanna Medlicott and Stella Thebridge.

Churches Together

The Churches Together ministers continue to meet monthly. They wrote a joint letter to the Mosque during the times of violent disorder to offer solidarity and prayers. A United Service was held at Sutton Baptist Church on 19th January 2025 at 6.30pm

(Prayer, social, Friends and Children and Young People are noted in other reports.)

Electoral Roll - Report to the APCM 6th April 2025

The preparation of a new electoral roll is required every six years. This year is the sixth year, so the old roll has been deleted and applications have been taken for a new roll. It has been publicised in the digital Newsletter, on the notice board in church and on service sheets from 24th January. An email was also sent to people on our existing contact list to make them aware. People have had the opportunity to use a "link" or a QR code to apply online, or complete an application form and hand it to me. The new roll was available for checking for two weeks, when final admissions/corrections could be made until Sunday 23rd March when it was closed. Any corrections were notified to me, and amendments made.

We started the year with 135 members, 3 members have passed away, David Gale, Ann Storey and Jean Schneider. There are many people who previously signed up for the purposes of proving regular attendance for marriage who have not signed up this time. There are still regular congregation members who have not signed up (for whatever reason) if they wish to be added to the new roll they will need to complete an application form and hand it to me after the APCM, when it will reopen.

The new roll stands at 78 members.

Eco Report for APCM, March 2025

In March 2022 the PCC decided that we should aim for the Gold Eco Church award, so we have been working towards this since then, latterly with Chris Chubb in the lead role. In January 2025 Chris resigned this role to work on the new website and, since I have always been interested in eco things, I have agreed to resume the role.

At the beginning of February 2025 the Eco Church questions changed, partly to align them more with the Net Zero goal that churches have been asked to aim for. The previous questions typically had a tick-box format, where you scored more if you did more of something. Also, Grade 1 listed buildings were automatically exempted from some of the questions. The new questions are more searching. You have to begin by setting out a plan for your buildings, your land, etc; you then have to make various eco-friendly changes; and then you have to write about how your changes link to your plan, and why you made various choices. Grade 1 listed churches are no longer exempt from any questions, although I have been assured that Eco Church will understand that it is not possible to do certain things (eg. double glazing) with such a church, but now you have to write and explain that you have considered this, and if you have found it is not possible you have to explain why. Therefore, achieving a Gold award will now be quite a lot harder for Holy Trinity Sutton Coldfield than under the previous questions.

Following an announcement in church that we are embarking on the project of working for a gold award under the new rules, both Mission Committee and the PCC have given this their backing. There has been lots of discussion amongst the congregation, and various helpful suggestions. The church children have helped to plant some small daffodils, and on Sunday 23rd March we shall plant some butterfly-friendly plants in the car park planter where we have previously grown fruit and vegetables including peas, beans and potatoes, also sunflowers, herbs and wildflowers.

Paul Medlicott has offered to use half the planter for gardening with scouts, which will help them achieve their gardening badge. I shall ask them to write some sound bites about what they do and to take photographs so that their gardening project can also contribute to our work for Eco Church.

I am still seeking two more people who are willing to be part of a team, with their roles being:

- helping to make the churchyard more wildlife-friendly: looking after an area of longer length grass, planting plants that attract butterflies, and other features
- Researching eco-friendly choices and what they would cost if we were to implement them

It will be helpful if each member of the team can write about their activities using sound bite quotes from different members of the congregation, and also take photographs of their activities. I will help with arranging these into a format that we can put on our website. This is a means by which we can display what we are doing that we will be able to use as part of our submission for the Gold award. When we were in the process of applying for the Silver award I had various conversations with the Eco Church team. They were very complimentary about our website and extremely keen that we should continue to display our eco-activities on it.

I would like to arrange for our Eco team to meet with Sheena Heaton from St Peter's who is now a Gold award judge and who has offered to answer our questions, and also with Jonathan who is the clergy Eco lead in our OA. The meeting will help us in drawing up plans for our Eco activities under the five Eco Church headings.

In the meantime:

- Some of us have signed up to Carbon Fast for Lent (counts towards both Lifestyle and Global Engagement)
- Those leading our service on 23rd March have agreed that we will participate in Earth Hour as part of the service (counts towards Global Engagement)
- Stella and I have selected an area of the churchyard in which we will allow the grass to grow longer and Stella is emailing the Park Rangers to arrange this (counts towards Land and Nature).
- I have ordered 10 water testing kits so we can take part in the Great UK Water Blitz over the weekend of 25-28 April. These kits were offered free of charge, then at a later stage they invited me to donate their cost: £10 per kit, so they were asking for £60. I chose to take the kits free of charge, but we could perhaps consider donating something to *Earthwatch* who are organising the event: earthwatch.org.uk

We also currently have planned:

More of the monthly walks in Sutton Park which Mary has so ably organised.

A plant sharing and perhaps also a book sharing/sale in May, with people who don't bring something being asked to give a donation to Christian Aid. Paul Medlicott has kindly offered to arrange this. The date is not yet confirmed as it may coincide with either the VE Day service or the Civic service, so we are waiting for details of these services before choosing a date.

Eco Spots to be published in the Newsletter, along with articles in Trinity.

Report from Prayer co-ordinator for APCM 2025

Prayer after communion – we continue to offer prayer during the fourth Sunday service for anyone who would like prayer for themselves or someone they know for any reason, not necessarily for healing. There will be someone there to pray with you. Please go there after you have received communion.

Annual General Meeting Report on Website Transition

Why the Switch Took Place

The switch from the old M3 website developed in 2018 to the new Wix platform was initiated due to significant limitations in functionality. Additionally, maintaining the old site through M3 would have cost £2150 per year despite being unsupported, vulnerable to cyber attacks, and lacking essential updates. M3 also quoted a prohibitive £40,000 for a complete rebuild. In contrast, Wix offered a fully supported, secure solution at a substantially lower cost of £300 for a two-year contract, with additional benefits outlined below. The goal was to enhance our online presence, improve user experience, streamline administrative processes, and achieve better cost efficiency.

Period of Transition

The transition occurred over several weeks, starting in mid-January, and was fully completed by February 6th, 2025. The timeline was compressed due to the renewal date with M3, roughly 80% of the old website was transferred to the new site, with some content being out of date and left behind. Regrettably, some content was missed due to the limited time to transition. The missing content is being reinstated over the coming months.

Functionality of the New Website

The new website, hosted and managed via Wix, offers:

- User-friendly content management for quick updates and flexibility.
- Integrated CRM (Customer Relationship Management) capabilities.
- Seamless integration for event listings, ticket sales, and payment processing.
- Enhanced visitor analytics, providing detailed insights into visitor behaviours and site interactions.
- Improved mobile compatibility, catering to the 74% of users accessing via mobile devices.
- Increased cyber resilience through Wix's robust security measures.
- Enhanced capability for receiving donations securely online.
- Ability to accept payments via credit/debit cards as well as mobile options like Apple Pay and Google Wallet.

Benefits to Friends for Events and Ticket Sales

The new website significantly benefits the Friends of Holy Trinity Church by:

- Providing a straightforward platform for promoting events.
- Streamlining ticket sales directly through the site, reducing administrative workload.

 Allowing effective management of attendee data, facilitating better follow-ups and community engagement.

Financial Implications

Financially, the new platform incurs modest subscription and transaction fees. Moving to Wix has saved Holy Trinity a minimum of £4,200 over the next two years, not to mention the cost of a rebuild which was quoted at £40,000. There was also the potential for a cyber attack which would have been costly both in terms fines but also reputation.

The ongoing Wix costs are offset by improved efficiency, increased ticket sales due to better user experience, and reduced administrative overhead. Long-term, the enhanced engagement is expected to positively impact overall revenue generation for the church and its activities.

Conclusion

Overall, we are very happy with the performance and functionality of the new website. Friends have found the ticketing system to be a major improvement, significantly simplifying event management. We have observed a marked increase in traffic relating to the hire of Trinity Centre, with more enquiry forms being submitted than ever before. Additionally, we have successfully received multiple donations through the website.

Report to APCM 6th April 2025

The Friends of Holy Trinity continues to raise money to support the fabric of the church, with each of the concerts since the last APCM raising around £1K average. This is through a variety of performers, some of whom return by popular request.

Nick Revell has resigned as Chair but continues to oversee concert publicity. He leaves a workable system with each of the current committee overseeing a concert each, and Louise Chubb managing the account. We are very grateful to him for his work as Chair since the Friends was formed in 2013 (under his leadership) and we hope that someone will come forward to take on this co-ordinating role which is very straightforward now.

With continuing uncertainty about the church heating, the committee has taken on Becky Stephens' suggestion that we avoid the winter months for our programme in 2025/6 while we try to sort out a replacement system. So next season we will trial 5 concerts in total as follows, all Saturdays, and for which all artists are now confirmed:

- 1. 20 Sept (to coincide with Heritage Week)
- 2. 18th Oct
- 3. 14th March
- 4. 16th May
- 5. 27th June

Heritage

We have welcomed a number of groups to visit the church including Warwickshire Local History Society and Birmingham Heritage Forum. Stella has also met with individuals who have advised on various features of our church, notably the warden at St Leonard's Over Whitacre (about our font which was in their former church) and historian Jonathan Foyle. A number of school visits have been hosted by congregation members, notably Marian Baxter, Vivien Chubb, Nicola Revell, Stella Thebridge, Susie Walker and Karen Wright, to whom we are extremely grateful.

We held a series of 4 talks on aspects of Sutton's history during July and August which were well attended and very well-received.

All these events (and our concerts) raise our profile as a church and in some cases result in new people attending worship. We also raise funds from groups who give us a donation and/or buy merchandise and give donations for refreshments.

Plans are in hand for our Heritage Open Day on Sat 13th September (11am to 3pm – keep it free!) There will also be a number of other events on our site as part of the Town-wide programme overseen by Sutton Coldfield Heritage Network.

The first concert in a series which will lead in to celebrations of the 500th anniversary of the Town charters in 2027 and 2028 will take place on 5th April at Bishop Vesey's Grammar School. Discussions are also underway with a variety of partners across the Town for the celebrations as a whole.

Stella Thebridge, Friends Committee member; Heritage and history matters

Report on Stewardship 2024

- 1. Our church benefits from numerous gifts of time, talents and treasures from many volunteers in the congregation. We continue to be grateful for the range of generosity of all these which ensure that we can continue our mission and ministry. Nevertheless, there are always countless opportunities for you to show your commitment and support to Holy Trinity just offer!
- 2. Although the Treasurer is still to confirm our figures for the last year, since 2019 (pre-Covid) we have seen the total annual church giving (including gift aid and collections) reduce from £118k to £104k, which is a 12% reduction in 5 years. And that is despite some of our regular givers increasing their giving substantially during this time thankfully!
- 3. Whilst our last Stewardship Sunday only saw a limited increase in committed giving, we have seen a significant increase in one-off giving for the year. This, mainly through the Give a Little/ sum up card system and Donations table, is expected to result in a NET increase of £6-8,000 in giving for the year. This is something to celebrate, reversing the previous downward trend, and hopefully will continue with the recent addition of a new card donations furniture in church a bonus!
- 4. In 2025 we have only 60 committed planned givers (70 persons including couples), which is down from over 100 planned givers pre Covid. We had 141 persons on the last Electoral Roll. We must encourage more regular givers who commit to give weekly, monthly or annually whatever suits!
- 5. The average (mean) planned giving is £1,200 pa or £100 pm or around £23 pw. However, in contrast the middle (median) regular giving is £600 pa or £50 pm or around £11.50 pw. Unfortunately any fixed amount given to the church goes down in value each year due to ongoing inflation and this causes problems as our expenditure doesn't stand still with inflation and it increases our outgoings so perhaps we need a triple lock to be adapted?!
- 6. It is worth noting that a significant proportion (66%) of our planned giving comes from just 23% of regular planned givers. We have a limited number of our planned regular givers who increase their giving most years and whilst we are extremely grateful for that, this number is getting smaller each year unfortunately!
- 7. It is important that the church leadership at certain services through the year encourages the reasons for financial support to Holy Trinity. We need to attract more regular givers and encourage all to offer more substantial amounts where possible. We also need to maximise opportunities for NON-REGULARS to give to the church, especially at special occasions and seasonal services, baptisms and weddings etc opportunities not to be missed!
- 8. We currently have 10 (TEN) methods of donating/giving to this church: including Standing order, weekly envelope, gift aid envelope, cash plate, cheque, card, text, QRcode and website. In 2024 the Parish Giving Scheme was added as another option for people to consider, giving a wide range of options to choose from. However, it is important that any eligible givers agree to allow us to claim gift aid as this increases any such donation by an EXTRA 25% from HMRC so well worth it!
- 9. Finally, the need for everyone to have an up to date will and the opportunities for legacy giving to the church continues to be highlighted annually. Over the years such gifts- large

and small- have been of considerable help in supporting both the fabric and mission of the church and this hopefully will continue for the future – our church future!

Report from the Parish Administrator and Site Facilitator

The Trinity centre continues to be busy with community groups, commercial clients and church usage. New bookings include VIP record fairs, two new U3A groups and St John's Ambulance training (July – Dec 2024). We are still hosting the majority of public meetings for the Town Council, and we have local GPs in for training for 30 afternoons per year. All of these contributed to an improved turnover for the Trinity Centre last year.

It was decided to hold fewer parties in 2025 due to the logistical issues of managing big events. We are now managing to efficiently cover evening and weekend events with a combination of volunteers and self-employed stewards. We are extremely grateful to all who offer their time to help us support clients, in so many different ways – Thank you.

The Trinity Centre break-in, in November 2024, resulted in very little being stolen, but left us with a large amount of damage to the windows. We will take the opportunity to upgrade the windows, to improve thermal efficiency, using the money from the insurance claim. We are currently awaiting approval from the conservation officer before proceeding.

The Trinity Centre buildings committee have now applied to SCCT for a grant to improve the Trinity Suite and entrance way, which will hopefully be done during August 2025.

Other works done in the centre this year include:

- Electric fan heaters installed in Trinity Suite as a back up to unreliable gas heating.
- Work on the boilers in November 2024 to improve reliability.
- Leak around the ducting vent on the roof fixed.
- New lightning conductors installed in October 2024.
- Moss cleared off flat roof area.
- Recycling bins obtained, yet to be collected due to ongoing strike action.
- Improvements to telecoms resulting in a reduction in bills.

Safeguarding report for APCM 2025

Holy Trinity Parish Church and the PCC are wholly committed to ensuring that the church will be a safer place for all and thus have fully adopted the National Safeguarding Policy from the Bishops Guidance 2022 as our Safeguarding policy.

HTSC and the PCC will be diligent in:

- 1. Promoting a safer environment and culture.
- 2. Safely recruiting and supporting all those with any responsibility.
- 3. Responding promptly to every safeguarding concern or allegation.
- 4. Caring pastorally for victims/survivors of abuse.
- 5. Responding to those who may pose a present risk to others.
- 6. Being vigilant where vulnerabilities are identified and providing additional pastoral support through our Vulnerable Adults advocate.

The Parish Safeguarding policy was reviewed and updated in June 24 and is due for renewal in June 25.

Roles in Safeguarding:

Revd. Canon Becky Stephens remains active in ensuring Safeguarding policies are followed with due regard.

Tanya Arroba is our Vulnerable Adults Advocate.

Our Children's Advocate is Stella Thebridge.

Elizabeth Petley remains active in her role as Verifier for DBS checks and ensuring references are taken up when new volunteers are recruited.

Sunita Samuel was appointed as Safeguarding co-ordinator on 8.1.2025 and will be accessible through both email and telephone for any safeguarding concerns. Her contact information will be available on the website and we may look into displaying this information visibly in church via a poster or card.

DBS:

DBS for all volunteers requires updating every 3 years now. Thanks to Liz who continues in the role to ensure that all volunteers have up to date Disclosure and Barring Checks.

Training:

Safeguarding training is mandatory for all volunteers involved in activities with children, vulnerable adults and for those with roles in PCC as well as Church Officers. This is also valid for three years and needs to be updated if you are staying in the role. There are some of you with training requirements outstanding at last check. Thanks once again to Liz Petley who is currently maintaining an overview of this.

Activities with Vulnerable adults:

The Church does run activities with vulnerable adults, and it is now a requirement that volunteers in these roles undergo basic safeguarding training and DBS checks on a rolling three year basis.

These activities are:

- 1. Knit and Natter
- 2. Board Games
- 3. Anyone doing pastoral visits and Home Communion visits.

Risk Assessments:

Our warden Stella Thebridge is working towards completing Risk Assessments for the various activities that are run by the church to fulfil the requirements to promote a safer working environment. Thanks Stella.

Safer Recruitment:

HTSC is being diligent about adhering to the safer recruitment aims. All new volunteers to roles in the church are expected to be appointed after a suitability assessment and the uptake of references to corroborate their fitness to take on a position of responsibility.

Statement

'The PCC is committed to fulfilling its responsibilities to protect children, young people and vulnerable adults involved in all of the Church's activities.'

Brief Financial report yr end 31 Dec 2024

The process of simplifying accounts and moving to accounting software continues.

The Fabric and Renewal funds have been combined because in practise the renewal fund is all being used for the church fabric. We have now spent all of the restricted reserves in renewal and fabric funds which leaves us free to re-designate funds if necessary although the current plan is to leave designations unchanged.

From 1 Jan 2024 we have combined the Trinity Centre operations account and General account. So many of the costs (including salaries) are shared such that any allocation is arbitrary. We record costs and income specific to each building separately.

Friends is a designated fund now and made over £7000 in 2024. In practise profits from these events continue to be used for the Fabric of Church.

The attached statement of financial activity and balance reflecting the above shows restricted funds at 31 December, being Harlow Trust grant of £2,000 unspent, and restricted investments. The unrestricted funds covers Trinity Centre and General account as well as Fabric/renewal fund and Trinity Centre Maintenance fund.

There is a deficit for 2024 on unrestricted funds of £41.022. This is after £71,846 spent on Quinquennial works and Church heating for which we claimed listed places of worship grant of just under £17000 so a net cost of £54900 or so. Without this there would have been a £13,000 surplus for which the 2023 equivalent is £,2000

A large part of this improvement came from The Trinity Centre where income was up by about £15,000 but we have spent money on heaters in Trinity Suite, which will be costly to run, but are a back up to keep clients warm. Around £10,000 of this income came from St Johns Ambulance training contract which ceased in November but covered the cost of these heaters.

Income continues to exceed our regular costs despite constant price rises which is a vast improvement over recent years. We are still dependent on one off grants or income to cover periodic costly maintenance, but this is nothing new. Heating in both buildings need investment so at some point we may need to sell some of our investments.

Our total assets of £459,402 includes £372,501 of fixed assets and long term investments leaving about £85,000 of unrestricted reserves. We need to spend £9,000 on vestry roof. Our reserves policy is to retain 3 months spending which is around £60,000-65,000 at current levels. This means the spare "free" funds we have for unexpected costs total £10,000 to £15,000. Our finances have improved thanks to increased giving, and having more ways of giving via website and card reader.
